

# Half-Load Limit

## PUBLISHED BY AUTHORITY LOAD RESTRICTIONS/TRAFFIC CONTROL REGULATIONS

The following regulations have been made by the Town Council of Deer Lake under the provisions of section 414.2 (II) and (mm) of the Municipalities Act, M-24 S.N. 1999.

### 1. TITLE

These regulations may be cited as the Town of Deer Lake (Load Restrictions/Traffic Control) Regulations, 2009.

### 2. INTERPRETATION

In these regulations, unless the context otherwise requires,

- (a) "Council" means the Town Council of Deer Lake
- (b) "Municipality" means the Town of Deer Lake, the boundaries of which are defined by an Order in council entitled Town of Deer Lake Order 1950, dated the 27 day of may, A.D. 1950;
- (c) "Town" means the Town Council of Deer Lake
- (d) "Highway" means the entire width between the boundary lines of a highway, road, street, avenue, or thoroughfare, and for the purpose of these regulations, is intended to be defined in Section 2, subsection (ff) of the Highway Traffic Act.
- (e) "Vehicle" means a device in or upon which a person or property may be transported or drawn upon a highway.
- (f) "Street Reservation" means the land reserved for the public road, street, lane, sidewalk or public way.
- (g) "Authority" means the Town of Deer Lake

### 3. PROHIBITIONS

Be it resolved that the Town of Deer Lake adopt Half Load Road Limits under the authority granted the Town section 414 (II) (mm) of the Municipalities Act, Chapter M-24, S.N. 1999 which states:

- (II) prohibiting or controlling vehicular or pedestrian access onto or over a public highway or bridge;
- (mm) protecting and preventing injury to public highways, bridges and sidewalks and trees, plants and structures contained within a highway reservation, and providing for the

cleaning and removal of foreign matter from these public highways, bridges and sidewalks;

therefore be it resolved that, upon warranted situations and with appropriate notification of 48 hours - whether by letter or telephone notification to the affected parties or advertisement in The Western Star - that the Town of Deer Lake implement half load limits for all motorized traffic in areas of risk of damage to town property - whether it be roads, bridges or other town property - within the Town of Deer Lake.

**4. OFFENCES AND PENALTIES**

Failure to comply to is subject to further action under sections 419 and 420 and 421 of the Municipalities Act, Chapter M-24, S.N. 1999

**5. COMING INTO FORCE**

These regulations shall come into force as of Monday, November 23, 2009 as adopted at a Special Meeting of Council held Thursday, November 19, 2009 and as advertised in The Western Star, Saturday, November 21, 2009

**NOTE:** These regulations will remain in effect until otherwise publicized by the Authority.
